- 7. Grant application We were awarded \$2,500.00 of the \$10,000.00 we requested. In order to receive the \$2,500.00 we have until the end of May 2024 to spend it. There was a discussion to put \$5,000.00 with the \$2,500.00. There was a show of hands to see who wanted to add the \$5,000.00 with the \$2,500.00. Unanimous approval. Wayne and Harold to see if feasible to sink the well for \$7,500.00. Need to figure out where we want the building built in order to sink the well close to the building. Discussion to put the building on the north side of the driveway across from the rifle range. After first vote, there was one opposition to the placement of the building. After second vote, unanimous approval to measure for putting the building across from the rifle range if possible. Harold, Pat, Chuck and Kent Bignall to measure and stake out for the building. To meet June 28 at 6pm to measure. Future building to be approximately 30' x 40'.
