1. Call to Order – 6:30 pm

Approval of Prior Meeting Minutes

2. Minutes were reviewed for the December 19, 2023 meeting. A motion to approve the minutes by Chuck was made, Seconded by Kelly. Unanimous approval was given.

3. Treasurer's Report

- a. Kelly stated 3 bills have been paid. We have a \$46,251.50 CD, \$38,256.00 in checking, and \$600 was collected in memorium for John's passing. Motion to approve the Treasurer's report was made by Chuck, seconded by Dave. Unanimous approval.
- a. A 2024 budget proposal was given and read by Kelly. The 2024 budget proposal is similar to the 2023 budget. Wayne asked to have two hydrants added to the water system for projects for 2024. A vote was taken to add this project and it was unamiously approved. A Motion to approve the 2024 budget proposal with changes to add the hydrant project by Chuck was made, seconded by Dave. Unanimous approval was given.

1. Lake County Sheriff's Department Contract – John will follow-up with Harold about the contract.

New Business

- The new locks have been purchased and will be put in use on the last week of January. The code for the new lock, on the shed, will be different. If you need the code for the storage shed please call a board member.

They are requesting if the LCSC would apply for a liquor license for them for this event. Only a certain amount of licenses are permitted by any organization and they have none. They will cover all costs and including insurance A motion to approve the request was made by Wayne and seconded by Kelly. A unanimous approval was given by all present. John will follow-up with the liquor license. He will also check to see if we need to pick up a one day liability insurance and the cost.
- 6. Donations for 2024 were discussed. Dave brought up a donation to the MUCC for the work they do. A \$250 donation was suggested by Dennis. Dennis made a motion to support the \$250 donation and Dave seconded it. It was unaminiously approved for \$250 to be given to the MUCC for their work
