Board Meeting/Member Meeting

1. Call to Order – 6:29 pm

Unanimous Approval of Prior Meeting Minutes was given.

2. Minutes were reviewed for the March 2024 regular meeting. A motion to approve the minutes by Harold Nichols was made, Seconded by Ronald Dionne. Unanimous approval was given.

3. Treasurer's Report

Kelly presented the financial report. \$14,756 I checking, all bills are paid, \$1,900 in dues collected.

Old Business

1. Lake County Sheriff's Department Contract – Len tried several times to contact and negotiate a contract. Most of the time no calls were returned. Then the Deputy Sheriff said there was no money in the budget. Reed City club offered their range free for one year while the lake County Sheriff's department builds their own range as a plan. They didn't notify our club and removed all their equipment from our range. Dennis will send a letter to the Sheriff reminding them that they are not allowed to use the range from this day forward.
2. Raffle Tickets – Tickets are in and Board Members received theirs. Tickets are \$5 each or Qty. 5 for \$20. Kelly will schedule a day to assemble ticket packs. Pictures or posters of the weapons need to be made. Dave Werenko volunteered to take possession of the rifles for display purposes and selling tickets. He wants one gun per gun case to prevent damage. Harold made a motion for Dave to take possession of the rifles, only members with CPL's can possess the rifles. Kelly seconded the motion. All were in favor and passed. Dave will contact Jeremy to receive the rifles.
3. Promotional items – Greg Nichols Jr. will contact Chuck Brooks for a follow up. There is a \$1,000 in the budget.
4. Golf Outing – Bud reported there will be a golf outing on Sunday August 4th with dinner, lunch and prizes. Details are forth coming. May 3rd will be the next meeting to finalize the details at the VFW hall at 2 pm.

- Harold stated the porta Johns need to be scheduled. John Beech will schedule them for cleaning.
- **A work bee date will be April 30th at 9 am until finished.** All members are asked to volunteer and help clean the range and do repairs.
- Kelly asked permission to advertise the club in a local Irons paper. A 3x4 add is \$179. Harold made a motion to approve and Greg Nichols Jr seconded it. All approved and passed.
