Board Meeting/Member Meeting

1. Call to Order – 6:46 pm

2. Minutes were reviewed for the April 2024 regular meeting. A motion to approve the minutes by Harold Nichols was made, Seconded by Kelly Zoellner. Unanimous approval was given.

3. Treasurer's Report

Kelly presented the financial report. Kelly reminded Greg Nichols Jr. that \$1,000 must be returned to the clubs checking account from the trap league.

Motion to accept financial report by Harold Nichols, seconded by Greg Nichols Jr.. Unanimous approval.

Old Business

1. Lake County Sheriff's Department Contract – Sheriff Martin & Undersheriff Mark Pietras were present. Discussion was held regarding their needs. Calling ahead wasn't necessary for occasional one day training need. Advanced dates were appreciated by the club. The additional covered pistol shed for their pistol range was said to not be needed by Mark. The contract was signed by Sheriff Martin for the current year. Kelly will send the invoice
2. Raffle Tickets – Pictures to replace the actual rifles when selling were presented. Someone is needed to take the lead for scheduling of ticket sales was requested. Dave Weronko will ask his wife Cathy to be the scheduler. Kelly will forward all the information to John for now. She reiterated to only sell tickets that say **Thursday Drawing on them NOT SATURDAY.**
3. Promotional items – Dennis will look into pricing of hats, t-shirts and license plates by our July meeting.
4. Golf Outing – Bud reported there will be a golf outing on Sunday August 4th. Another meeting needs to be scheduled soon. Harold and Bud stated enough prizes will be on hand for the outing. There is a concern that we will have to turn away teams. A max of 110 golfers can play. If you are interested in participating get registered soon, as it will be first come first serve.
5. Hunting lease - A motion was made by Harold and seconded by Chuck to allow Dave Weronko to try again to lease the property for hunting. The vote was unanimous in favor. Dave currently has two bids and the mail will be checked one last time for any other bids.

New Business

1. Review of the meeting to discuss the concepts of our future club building/hall. Greg Nichols Jr. stated he checked with the building department. Any building we put up would be considered commercial. Prints of the building and all sub-structures such as electrical, plumbing would require prints. It can be built in stages. However, with a commercial building permitting is only allowed for "X" period of time. Every 6 months that the project is not done an additional fee of \$75+ would need to be paid. After two years the 6 month fees would go

up. Basically the clubhouse with all amenities and design would cost approximately \$225 k. We are not prepared to pay that at this time. However, it was determined to get a drawing made of the building desired as a start. Any member that knows of an engineer/architect that can produce a drawing of our required building is asked to call Harold Nichols at 231-510-2627.

2. Harold got pricing on material for hard paths for wheel chair access. 35 yards of stone for \$1,500. Chuck made a motion to approve the purchase not to exceed \$1,500 and Greg Nichols Jr. 2nd the motion. All approved and passed.
3. Sponsorship Policy – Tabled
4. Pat Groulx stated he can grub the trap field for \$80 per hour. Discussion was held on what needed to be done. Harold made a motion to approve the work not to exceed \$1000 to start the job, Chuck 2nd the motion. All approved and passed.
5. Ladies night shoot – ladies night was canceled for lack of an instructor, the program had good participation last year. We need to find a new certified woman to lead the program
6. Webber Twp. Outdoor day participation by LCSC cancelled due to a lack of volunteers from LCSC

- Kelly requested safety officers and volunteers for the June 15th Shoot
- Kelly requested a mowing of the grass before the shoot and it was approved.
- Pat Groulx suggested a banner to drape on the table when selling raffle tickets. Should say LCSC Gun Raffle. Motion by Harold Nichols and 2nd by Gregg Jr. Motion Approved and Dennis to purchase not to exceed \$150.

9. Adjourn Meeting – Motion to adjourn, 8:21 pm by Harold, seconded by Greg. Unanimous approval.
