Unapproved Meeting Minutes

1. Call to Order – 6:28 pm

2. **The Secretary's Minutes** were reviewed for the regular May20th, 2026, meeting. A motion to approve the minutes by Harold, Seconded by Bud K.. Unanimous approval was given.

3. Treasurer's Report

- All bills are paid.
- **Our current checking account balance is \$4,637.91, Savings \$25,010.44**
- **All current CD's total is \$92,639.91**
- **Dues are coming in steady**
 - Harold Made a motion to accept the current financial report as stated. Dennis seconded the motion to approve the current financial report as read. All approved.
- **Old Business**
 1. Harold said cameras are waiting for delivery.
 2. Dave Weronko & John Beach (Pat Groulx) will schedule for a day for excavation to construct new enclosure for second pistol range on West Pistol range. And to fill and level future site of club house. Pat gave a proposed invoice for \$10,500 for labor & materials. Discussion was held. Harold made a motion to approve paying the invoice. Dennis seconded the motion. All approved the motion and it passed.
 3. Reviewed safety officers available for June 20 3-Gun Shoot.
 - a We need members to bring a dish to pass. Club takes care of the meat.
 - b Harold will bring ice & water
 - c 10 a.m. is set up
 - d 9:30 a.m. will be trap training
 4. Kelly did a survey and we have 3 more people that volunteered to be safety officers.
 5. Kelly & Dave said we need more sellers for our raffle tickets. Dennis is to send an e-mail to all members requesting volunteers.
 6. We need a volunteer to sell with Kelly on June 27th with Kelly at the Dublin Store. Please call Dave Weronko.
 7. Bud – Golf outing on track for Sunday August 2nd Dennis to send board members a list of last year's donators for club members to help get donations from.

New Business

Special meeting was held previous to this regular meeting.

1. With the gate locked to the range; the trap machine was found running, damaged and most of the clays shot up. No money in the collection box, no sign in sheets used. After much discussion it was decided to
 - a.) temporarily shut down the electronic/automated trap machine,
 - b.) change the locks on the trap shed
 - c.) make the hand thrower available to members,
 - d.) members bring and use their own clays until a permanent plan is in place for the automated trap equipment.

After much discussion, it was decided by the board to:

- a. **The board has decided, because of the damage done to the TRAP equipment and clays, all members who wish to shoot clays and use the trap equipment must be recertified with our equipment. The locks have been changed for access to the trap shed/house. Locks will be changed on a more frequent basis.**
 - b. **To have access to the new locks, you must go through the training again. Your prior training no longer counts. Our first training is this Saturday before the 3-gun shoot at 9:30 a.m. at the range before the 3-Gun Shoot.**
 - c. **Please e-mail me to schedule additional training dates at karczyskid@yahoo.com. As soon as I hear from our members that want the training, we will schedule dates that will hopefully meet your schedules. Sorry for the inconvenience and thank you for your patience in this matter.**
2. Troutarama is in July, Bud should sell Guitar tickets at car show there.
 - a. Harold asked for a motion to pay \$100 to the Troutarama committee for our name on the banner. Bud made a motion to buy a spot on the banner. Dennis Seconded the motion. All voted in favor of buying the ad on the banner. Motion passed.
 3. Harold asked for a motion to repeat last year's appreciation food for Ace Hardware & Dublin for letting us sell tickets repeatedly every year. Harold made a motion to approve spending \$100 on food for Ace Hardware & \$100 for Dublin employees. Dennis seconded the motion. All voted in favor to approve the motion. Motion passed.
 4. Dave & John said that GEO & the Sheriff's department agreed on the pistol range enclosure. The Groulx brothers will begin to move the berm and excavation work. Each enforcement agency will have a shed by the pistol range. It was discussed and agreed to spend the \$7500 grant and make an enclosure big enough for the organizations.
 5. Harold investigated, received a quote for gravel needed for the range. Previously it was approved to purchase gravel, however, the minimum amount now is a pup trailer load. It is crushed concrete and the cost is \$2400 for a full pup truck, approximately 26 – 30 yards. This load will be some that is already approved, plus, additional gravel to meet the minimum. Kelly made a motion to accept the quote and purchase the gravel. Dennis seconded the motion. All voted in favor. The motion passed.

Round Table

- Kelly said we received a thank you note from recipients of our donation to Comfort Home.
- Pat was asked to get 5 (3) foot boulders to put in front of the trap range to prevent vehicles from running over the equipment. He will provide a quote.
- Dave asked about bids for a hunting lease for our property as in the past. All agreed for Dave, as vice president's duties, to run the bid process for leasing the property to all current members.
- Cameron Harwell, running for the prosecutor position, introduced himself and his platform.

Adjourn Meeting – Motion to adjourn by Dave W.. 2nd the motion, Kelly unanimous approval.
