Approved Meeting Minutes

1. Call to Order – 6:27 pm

2. **The Secretary's Minutes** were reviewed for the regular June 16th, 2026, meeting. A motion to approve the minutes by Harold, Seconded by Bud K. Unanimous approval was given.

3. **Treasurer's Report**

- All bills are paid.
 - Our current checking account balance is \$2,190.55, Savings \$18,025.46
 - All current CD's total is \$92,639.91
 - One bid for leasing the property for hunting came in from Sean James and was accepted.
 - Kelly stated we were over budget on range maintenance because of the excavation being done. Harold pointed out that it was recorded on the wrong line-item of the budget and should be corrected.
 - Kelly asked if the Trap savings account could be closed. It costs \$5 a month to keep open. She would make a separate line-item in the current budget to account for their money. Harold made a motion to approve Jim Seconded. All passed in favor.
 - Bud K. Made a motion to accept the current financial report with changes to excavation line-item. Jim Y. seconded the motion to approve the current financial report as read. All approved.
- **Old Business**
1. Harold said the cameras were not delivered and everyone needs to look for cameras, not internet or phone account based. If we do not by next meeting a decision to pay for internet-based cameras will have to be decided.
 2. Dave Weronko & John Beach (said they sold over \$600 in tickets at the Trou-o-Rama. But we need volunteers to sell more. We've only sold about \$3,000 in tickets so far.
 3. Bud – Golf outing on track for Sunday August 2nd. We currently have 21 teams. We need volunteers to solicit other businesses for donations. Dennis sent the list out.
 4. Tom Evans, current prosecutor for Lake County presented himself and his platform. He is running for election.
 5. Dave, John & Dale said the excavation status is done and in good shape.
 6. Dave & John said Rex is coming out to review the pistol range cover needs and will provide a quote of materials needed and labor hours required.

New Business

1. Kelley asked for a donation to the kid's program "Hunt of a lifetime". It gives terminal children a chance to hunt or fish. Harold made a motion to donate \$200. Bud seconded the motion. All were in favor and the motion passed.
2. Dave W. discussed accessibility walk-ways for the range and is still investigating methods.
3. Kevin stated he finished his training for "Hunter's Safety Classes" and needs to work under a mentor for one class. He will look to other clubs for an opportunity to participate and be mentored. This will allow him to conduct classes at our range.

Round Table

- Kelly said we received a thank you note from recipients of our donation to Comfort Home.
- Pat was asked to get 5 (3) foot boulders to put in front of the trap range to prevent vehicles from running over the equipment. He will provide a quote.
- Dave asked about bids for a hunting lease for our property as in the past. All agreed for Dave, as vice president's duties, to run the bid process for leasing the property to all current members.
- Cameron Harwell, running for the prosecutor position, introduced himself and his platform.

Adjourn Meeting – Motion to adjourn by Harold N. 2nd the motion, Greg Jr.. unanimous approval.
